- c) Township of O'Connor Union Agreement – Article 17 with regard to Paid Holidays was read with regard to the new Provincial public holiday "Family Day". At the January 28<sup>th</sup> meeting it was decided that the staff would not receive this holiday in 2008 and that it would be discussed further during Union Negotiations later this year. The Clerk-Treasurer was asked by Council to check to see what the Union Agreement states in this regard. The agreement does state "the Employer recognizes the following paid holidays... and "Any other day proclaimed as a holiday by the Federal, Provincial or Municipal Government. It was then agreed that the Township employees will be entitled to this holiday in 2008.

Councillor Racicot returned to the meeting.

Under New business, Council discussed

- a) Thunder Bay District Municipal League requesting upcoming events to put on their events calendar. Council agreed to give the information on the following events: Paul Goulet Fire Fighters Competition, the Strawberry Festival and O'Connor Day.  
b) Ministry of Municipal Affairs and Housing report showing the Township of O'Connor's 2008 Annual Repayment Limit.

Under further new business, Council discussed an issue of concern for the Lakehead Rural Planning Board. The Municipality of Oliver Paipoonge is having trouble with an approval process for subdivisions in their municipality. The Ministry of Municipal Affairs and Housing is encouraging no growth in the area and they have stated that in the unorganized territory there will be only 200 parcels allowed between 2007 to 2017.

Councillor Garbutt reported on the CPAC meeting she attended. The 4<sup>th</sup> quarter incident report shows an increase in calls for 2007. This will be available at the next meeting. False alarm calls have become an issue. The 2008 billing will be increasing for police services.
