Mayor Nelson called the meeting to order at 7:00 p.m..

Mayor Nelson welcomed Mr. Malek, a biochemist of Lakehead University, to the table and introductions were made. Mr. Malek apologized for missing the February 25, 2008 meeting he was scheduled for. He gave Council a brief history of himself and his work and explained what he would like to do within the Township of O'Connor. As a follow up to a recent study of the agricultural land use in the area Mr. Malek would like to contact the residents of the Township of O'Connor to get their attitudes with regard to land use. He would like to ask them to fill out a survey with regard to past, present and future use of their lands. Mr. Malek is concerned with the declining agricultural land use in the area and would be looking at the possibility of introducing high value, novelty and energy crops. Mr. Malek is seeking Council's approval for the project in the Township of O'Connor and asking for contact information of our residents. Council do feel that it is a worthwhile project however Mr. Malek was informed that the Township cannot give out personal information of our residents, but we would be willing to put information in our newsletter "the Cornerstone". The information in the article could include what his intentions are and his contact information. The residents of O'Connor can either contact the township office if they are willing to participate or contact him directly. Mr. Malek will submit information for the April Cornerstone. Council thanked Mr. Malek for attending.

Fire Chief, Henry Mattas was welcomed to the table. The Fire Department report was read. There have been no calls since the last report. Two new members have joined the fire department. Fire Chief Mattas reported that some members of the department are registered for the upcoming local training sessions. These include the CO 101 legislation, volunteer Firefighter Module A and Flashover. Fire Chief Mattas reported to Council that the fire fighter's competition may have to be cancelled or the date changed this year as the Office of the Fire Marshal has scheduled courses in the area on the same date, as well, as discussed at a previous meeting, the Municipality of Neebing's fire department will be hosting a family event in their municipality on that same date. The equipment required for the competition is currently in White River and also needs to come back to the area.

Fire Chief Mattas informed Council of a possible meeting between the Fire Chiefs and the local MPPs with regard to any local issues they might have as well as requesting needed money for the departments from the provincial government. Mr. Hammer of Greenstone may be making the arrangements.

Fire Chief Mattas has been asked by Mr. Olaf Lamerz, Fire Protection Officer of the Office of the Fire Marshal, to provide an itemized status report relating to the training audit recommendations that were made for the department last fall. Fire Chief Mattas presented his response for Mr. Lamerz to Council, prior to his submission. In regard to the training of the members, Fire Chief Mattas reported that the department is using the Essentials of Fire Fighting Manual from the International Fire Service Training Association. Council asked the Clerk-Treasurer to contact the publishers to confirm that it's content is recognized in Ontario as sufficient training.

Compensation for the volunteers of the department attending fire training and meetings was discussed. A lot of the required training for the fire department members is taking place both during the weekday and on weekends. Members have to take time off work to attend, which at times can discourage members from attending. As well weekly training sessions do take time away from their families. A honourarium for attendance at full day meetings, weekly training sessions and calls was discussed. The Fire Chief along with the Clerk-Treasurer will get together and come up with what would be a fair honourarium to pay these volunteers and this information will be brought back to Council for review.

The Fire Department has been checking over all of their equipment and it was noted that new helmets are required and the turnout suits are coming due for replacement soon. The forest fire equipment is ready for spring.

It was brought to Council's attention that some departments have Council appoint each member of the fire department by by-law. Fire Mattas reported that he spoke with Mr. Kembel, a specialist with the Office of the Fire Marshal, and he said that it was recommended but not necessary. Council asked Fire Chief Mattas to inquire into the pros and cons of the appointment by by-law.

Fire Chief Mattas was thanked for attending.

It may be rescheduled later in the year. Council at a previous meeting decided to donate township pins for the meeting. The pins have not been sent.

Councillor Racicot has been Past President for a longer term than anticipated due to the municipal election and the President of the league not being reelected in his municipality and this year the first vice-president did not want to step up to President so Councillor Garbutt will remain as President for another year, again leaving Councillor Racicot as Past President. The concern being that our small township will be covering the costs of the honourariums for our members for another term. Councillor Garbutt will be discussing the electrical process at the next Municipal league meeting.
