

THE CORPORATION OF THE TOWNSHIP OF O'CONNOR
BY-LAW NUMBER 2002-17

Being a by-law to establish miscellaneous fees and charges for the Corporation of the Township of O'Connor.

WHEREAS The Municipal Act, 2001, c.25, Section 392, requires a municipality and local board to establish and maintain a list for public inspection indicating which of its services and activities and the use of which properties will be subject to fees or charges under this Part and the amount of each fee or charge.

NOW THEREFORE THE COUNCIL OF THE CORPORATION OF THE TOWNSHIP OF O'CONNOR HEREBY ADOPT THE FOLLOWING MISCELLANEOUS FEES AND CHARGES:

1. Equipment Rates
 - a) Grader - per hour, minimum one hour \$75.00
 - b) 420 Cat Backhoe - per hour, minimum one hour \$70.00
 - c) Truck- per hour, minimum one hour \$70.00
 - d) Snowplowing - price to be at the discretion of the Leadhand, charged as per size of driveway, average charge \$37.00
 - e) Installation of entrance culvert - the actual costs of culvert, collar and gravel, plus labour
 - f) Steaming Culverts – per hour, minimum one hour \$50.00

2. Cornerstone
 - a) Advertising - Full page ad \$10.00
 - b) Advertising - Business ad \$5.00
 - c) Advertising - Personal and Classified ad \$2.50
i.e. - garage sale, for sale item
 - d) Advertising - Announcement \$1.00
i.e. - birthdays, anniversary, new baby
 - e) Individual addressed mailing of Cornerstone to non residents and/or non taxpayers Annual fee \$20.00

3. Hall Rental Fees
 - a) Socials with Liquor \$150.00
 - b) Half Day Rental - no liquor \$50.00
 - c) All Day Rental - no liquor \$100.00
 - d) Use of Kitchen \$25.00
 - e) Non-Profit Groups - Brownies, Guides, TOPS, Community Bridal Showers, Jackrabbits - no charge for meetings but a donation for the use of the hall may be accepted. Any event where a profit is being made, these groups will be charged for the use of the hall.
 - f) Damage Deposit may be required \$50.00
 - g) O'Connor Women's Institute, O'Connor Community Club and the O'Connor Fire Department Auxiliary are exempt from all hall rental fees.

4. Disposal of a Dead Animal - as per policy \$50.00
5. O'Connor Free Methodist Cemetery – Interment Charges
 - a) Summer Interment \$450.00 (May 1st to October 31st)
 - b) Cremated Remains Interment \$125.00 (May 1st to October 31st)
 - c) Winter Interment \$550.00 (November 1st to April 30th)
 - d) Saturday Interment \$550.00
6. Miscellaneous fees
 - a) Lottery Licenses \$5.00
 - b) NSF cheque – service charge \$35.00
 - c) Photocopies \$.15
 - d) Photocopies – non-profit groups 0 – 25 free
- non-profit groups over 25 copies \$.05
 - e) Township maps 8 ½” x 11”, 8 ½” x 14” free
- large maps \$10.00
7. A copy of this by-law shall be included in the public listing of fees and charges
8. This By-law shall come into force and take effect on the 19th day of December, 2002.
