

THE CORPORATION OF THE TOWNSHIP OF O'CONNOR
BY-LAW NUMBER 2012-25

Being a by-law to establish miscellaneous fees and charges for the Corporation of the Township of O'Connor and to repeal By-law number 2002-17 as amended.

WHEREAS The Municipal Act, 2001, c.25, Section 391, (1) authorizes a municipality to impose fees or charges on persons, (a) for services or activities provided or done by or on behalf of it; (b) for costs payable by it for services or activities provided or done by or on behalf of any other municipality or any local board; and (c) for the use of its property including property under its control.

NOW THEREFORE THE COUNCIL OF THE CORPORATION OF THE TOWNSHIP OF O'CONNOR HEREBY ADOPT THE FOLLOWING MISCELLANEOUS FEES AND CHARGES:

1. Road Department
 - a) Grader – per hour, minimum one hour \$ 95.00
 - b) 420 Cat Backhoe – per hour, minimum one hour \$ 90.00
 - c) Truck – per hour, minimum one hour \$ 90.00
 - d) Installation of Entrance Culvert – the actual costs of culvert, collar, gravel and labour
 - e) Steaming Culverts – per hour, minimum one hour \$ 50.00
 - f) Snowplowing – price to be at the discretion of the Leadhand Charged as per size of driveway, average charge \$ 50.00

2. Administrative
 - a) Compliant Review Request (Council Code of Conduct) \$125.00
 - b) Lottery License \$ 5.00
 - c) NSF Cheques – service charge \$ 50.00
 - d) Fax \$ 1.00
 - e) Photocopy \$ 0.15
 - f) Photocopy – non-profit groups 1 – 25 copies no charge
non-profit groups over 25 copies \$ 0.05
 - g) Disposal Site Permit – replacement or extra permit \$ 5.00

3. Cornerstone
 - a) Full-page advertisement \$ 30.00
 - b) Business advertisement other than full-page \$ 10.00
 - c) Personal and Classified advertisement – i.e. garage sale \$ 5.00
 - d) Announcements – i.e. birthdays, anniversary, new baby \$ 2.00
 - e) Individual addressed mailing of Cornerstone to non-residents and/or non-taxpayers - Annual fee \$ 25.00

4. Hall Rental	
a) Social with liquor	\$200.00
b) Hall rental – no liquor	\$ 75.00
d) Use of basement Kitchen	\$ 50.00
e) Community Involvement Programs – Three (3) months startup no charge after three (3) months 10% of individuals participation fee	
f) Non-profit groups – i.e. Brownies, Guides, TOPS, O'Connor Free Methodist Church, O'Connor Conmee Baptist Church – no charge for meetings, however a donation for the use of the hall may be accepted. Any event where a profit is being made then these groups will be charged for the use of the hall as outlined in this by-law.	
g) O'Connor Community Club and the O'Connor Fire Department Auxiliary are exempt from all hall rental fees.	
5. O'Connor Free Methodist Cemetery – Interment Charges	
a) Summer Interment – May 1 st to October 31 st	\$450.00
b) Cremated Remains Interment – May 1 st to October 31 st	\$125.00
c) Winter Interment – November 1 st to April 30 th	\$550.00
d) Saturday Interment	\$550.00
6. Disposal of a Dead Animal – as per policy	\$ 50.00
7. O'Connor Cemetery Fee Schedule	
a) Sale of Interment Rights (Lots) (Care and maintenance Fund - \$250.00)	\$300.00
b) Sale of Interment Rights for Cremated Remains in Cremated Ashes Garden (Care and maintenance Fund - \$150.00)	\$200.00
c) Flat Marker over 172 sq. inches	\$ 50.00
d) Upright Monument up to 4 ft in height or width	\$100.00
e) Upright Monument over 4 ft in height or width	\$200.00
f) Interment Charges	
Summer Interment	\$300.00
Cremated Remains Interment	\$175.00
Winter Interment (Nov 1 st – Apr 30 th)	\$400.00
Holidays/After Hours (with the exception of Sunday)	\$400.00
(Hours are 8:00 a.m. to 4:30 p.m. Monday through Friday)

Summer	\$400.00
Winter	\$500.00

That By-law numbers 2002-17, 2004-04, 2007-06, 2008-15, 2009-05, 2009-15, 2010-03 be repealed in their entirety.

This By-law shall come into force and take effect on the November 12, 2012.
