Under Further Old Business, Council asked if new, wired security cameras for the municipal yard should be included in the 2020 budget. It was noted that this item was cut from the 2019 budget. It was agreed to continue using the current battery-operated cameras until the cameras die and then Council can once again look at whether or not to get new ones.

Under New Business, Council discussed

a) Thora Cartlidge, Agriculture Development Advisor, Ontario Ministry of Agriculture, Food and Rural Affairs letter requesting support from the Thunder Bay District Municipalities for research into the barriers to attracting and retaining large animal vets in underserviced areas of northern Ontario. The research would be done through the OMAFRA/University of Guelph Research Alliance. A draft supporting letter was provided. The Clerk-Treasurer noted that she reached out the Veterinary Committee Council members and the Mayor earlier as a response was requested by May 8th. Council agreed to submit a letter of support.

Under Further New Business, Mayor Vezina noted that he received an email from 360 Studios, a virtual tourism photography and production company. They are trying to help restart communities following COVID-19 by creating a virtual tour of municipalities to allow local and future visitors to see all that the area has to offer, while planning their next trip, when it is safe to do so. There is an estimated cost of \$1,200. Council agreed that this would not be a priority at this time.

Issues brought forward or letters received after the agenda was mailed out were read as follows. These items were emailed to Council prior to the meeting.

- a) Solicitor General regarding the amendment made to the Police Services Act (PSA) to prescribe a new deadline for the completion and adoption of the Community Safety and Well-Being (CSWB) Plan. The Clerk-Treasurer reported that the four municipalities in the Lakehead Police Services Board (LPSB) are working together to create this plan under the lead of Rosalie Evans. The deadline has now been extended to January 1, 2021.
- b) Lakehead Rural Municipal Coalition (LRMC) i) Minutes of the March 3, 2020 meeting.
 - ii) Administrative Report regarding Matters arising out of the March 3, 2020 meeting.
- c) The District of Thunder Bay Social Services Administration Board (TBDSSAB) –
 i) Regarding the TBDSSAB 2019 Levy Surplus Disposition. The Township of O'Connor will receive a refund of \$742.
